

You were in a car accident... Now what?

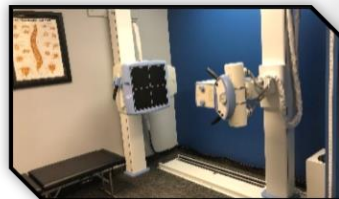
